MUSIC LESSONS / COST

Music lessons are for 30 minutes duration conducted during the school day with an Instrumental Music Instructor. The cost is **\$55.00 per lesson**, inclusive of GST and will be invoiced to parent / guardian / carer at the conclusion of each Term from the College Fees Team.
